- Renewals are \$410, or you can file a fee waiver application (Form I-912)

# Work Authorization Based on a Pending Asylum Application



Timeline



**Day 1:** I-589 is filed with USCIS or the Immigration Court



**Day 150:** Asylum applicant can apply for work authorization with USCIS

**Day 180:** Asylum applicant is eligible for work authorization

#### Example:

<u>January 1, 2024</u> – I-589 Asylum Application is filed

May 30, 2024 – Form I-765 can be filed with USCIS

June 29, 2024 – Applicant is eligible for work authorization

# Work Authorization Based on a Pending Asylum Application



The clock can stop



**Day 1:** I-589 is filed with USCIS or the Immigration Court



**Day 150:** Asylum applicant can apply for work authorization with USCIS

**Day 180:** Asylum applicant is eligible for work authorization

#### **Applicant Caused Delays:**

- A request to transfer a case to a new asylum office
- Amotion to change venue with the Immigration Court
- A request to reschedule an asylum interview with USCIS for a later date
- A request more time to find an attorney with the Immigration Court
- Failure to appear at an interview or fingerprint appointment.


# Work Authorization Based on a Pending Asylum Application
